

COMPREHENSIVE PRIVACY NOTICE

Video Surveillance

In compliance with local regulations on personal data protection (hereinafter the “regulations”) and other applicable provisions, and so that you can make informed decisions about how we can process your personal information, we provide you with this notice that details the use of your personal data, identifying the entity responsible for your information; the purposes or actions that motivate the collection, use and custody of your personal data; the third parties to whom your personal data will or may be transferred; the mechanisms for you to exercise your rights, among other information.

This Privacy Notice will be made available to people who have been video recorded by our video surveillance system (CCTV) installed by Arca Continental, either in its facilities or in public spaces where Arca Continental operates. In addition to being provided and communicated by physical or electronic means, people recorded by the video surveillance system may consult this privacy notice through our website, available at the following link: [Video Surveillance Privacy Notice](#)

In addition to being provided and communicated by physical or electronic means, people recorded by the video surveillance system may request a copy of the latest version of this document through the local Data Protection Officer, whose contact information can be found in the International Section of this notice.

Who is responsible for your personal data?

“ARCA CONTINENTAL” is a corporate group with an international presence and, for this reason, through this document we provide you with the necessary information to identify the local entity that will be responsible for your personal data.

For the purposes established in this Notice, the entity responsible for your personal data will be the one that initially collects your information through physical or electronic means. You can find the name of said entity in the contractual and/or commercial information that links you to us.

The complete list of ARCA CONTINENTAL Responsible Entities, as well as addresses for hearing and receiving notifications, in each country, is available in Annex 1, attached hereto. Each entity will be individually referred to as “the Controller” in this Notice.

What data do we use, and can we request?

For the purposes established in this Privacy Notice, the Controller may process the following categories of personal data:

- Image

What will we use your personal data for?

1. Security of the Controller's assets and facilities.
2. Security of people who visit and/or work at the Controller's facilities.
3. Access control of our personnel, as support for the attendance controls implemented by the Controller.
4. Provide access to or copies of sections or fragments of video recordings to the competent authorities, for compliance with duly founded and motivated information requirements.
5. Provide access to or copies of sections or fragments of video recordings to duly authorized personnel of the Controller, for the fulfillment of supervision and control functions of our personnel.
6. Conservation of records, for the time strictly necessary for the fulfillment of the purposes indicated above.

The Controller will process your personal data for the following purposes necessary for the fulfillment of our legal and/or commercial relationship.

Who can we share your data with?

Your personal data may be transferred within Mexico, Ecuador, Argentina and Peru or abroad, to the following categories of recipients and for the purposes identified:

- National, federal, state and/or municipal administrations and authorities; commissions; institutes, regulatory entities; judicial or administrative authorities; and government entities of the countries where we operate and/or foreign countries, for compliance with information, transparency and fraud prevention obligations, crimes or other illicit activities, as well as for compliance with judicial or administrative requirements issued by those authorities.
- To our parent company, subsidiaries, and/or affiliates that operate under the same internal processes and policies, for the purposes of management, administration, and centralized information safeguarding.

Any additional transfer of your personal data that requires your consent will be informed in advance, through the communication and update of this Privacy Notice and prior to the realization of that data communication.

Rights of Personal Data Owners

The regulations govern specific rights for personal data owners; these rights are generally known as “ARCO rights” and include the following:

- **Access:** the right you have to know what data we have about you, as well as to know how we use or share it.
- **Rectification or Inclusion:** the right you have to request at any time the rectification of your data, if for any reason they are incorrect, inaccurate, or incomplete in our databases.

- **Cancellation:** the right to request that we eliminate your information, starting from its blocking and its subsequent definitive deletion.
- **Opposition:** the right you have to indicate a legitimate reason why we should stop using your personal data.

In some countries, these rights also include:

- **Portability:** the right to obtain a copy of your personal data in a structured electronic format, which allows you to continue using them before another controller.¹

To exercise any of your rights, you must submit a request addressed to the Personal Data Officer of your locality, through the means established in the international section of this Notice.

The request must contain or be accompanied by:

1. Your full name and address, or another means to communicate the response to your request.
2. Copy of an identification/ID card (or power of attorney, if someone exercises the right on your behalf):
3. A description of the right you want to exercise, as well as the information related to it; and
4. Any other information you consider important to address your request or locate your personal data.

The Controller will respond to your request within the business days following the date it is sent and received, as established by local regulations. To exercise your ARCO rights, please complete the ARCO Rights Exercise Form, available in Annex 2 attached to the privacy notice. This form provides the necessary elements to ensure that your request will be addressed in accordance with current regulations. If the request is appropriate, we will make it effective within the business period marked by the local regulations following the date on which the response is communicated. In the event that the information and/or documentation provided in your request is incomplete, erroneous and/or insufficient, or the necessary documents to prove your identity or the corresponding legal representation are not accompanied, we will request the correction and rectification of the deficiencies in order to process said request.

The use of electronic means for the exercise of ARCO Rights authorizes the Controller to respond to the corresponding request through the same means, unless you indicate another means of contact in your request, clearly and expressly.

The right of cancellation is not absolute. Please consider that the Controller must keep information to comply with various legal obligations and that to do so it may share your personal data with other entities or organizations. In such cases, it is possible that the right of cancellation must be requested of the Responsible Entity of Arca Continental that received your personal data.

CONSERVATION OF PERSONAL DATA:

Personal data will be kept for no longer than necessary to fulfill the purpose of its processing. To ensure that personal data is not kept longer than necessary, the Personal Data authority or the data controller will establish the legal terms in accordance with the applicable regulations, for its deletion or periodic review.

UPDATE OF THE PRIVACY NOTICE:

Due to the continuous improvement of our processes, ARCA CONTINENTAL may make corrections and updates to this Privacy Notice at any time and without prior notice. INTERNATIONAL PARTICULAR PROVISIONS FOR MEXICO, ARGENTINA, PERU AND ECUADOR

MEXICO

Personal data owners located in Mexico must observe the following specific provisions:

Secondary purposes: do not exist.

ARCO Rights

The owner may exercise their rights of access, rectification, cancellation or opposition by sending an email to derechosarcomx@arcacontal.com , indicating the known name of the Data Controller, the reasons for their request and including information or documentation that allows them to be identified (for example, name and address), as well as a clear description of the personal data in relation to which they wish to exercise any of the rights.

The Data Controller will respond to your request within 20 (twenty) business days following the date it is sent and received. If the request is appropriate, the Data Controller will make it effective within 15 (fifteen) business days following the date the response is communicated. In the event that the information and/or documentation provided in your request is incomplete, erroneous and/or insufficient, or the necessary documents to prove your identity or the corresponding legal representation are not attached, ARCA will request the correction and rectification of the deficiencies in order to process your request. You will have 10 (ten) business days to address the requirement and correction of the request; otherwise, it will be considered not submitted.

Revocation of consent and limitations on the use of your personal data

You may revoke your consent for the processing of your personal data, without retroactive effects, in all those cases in which said revocation does not imply the impossibility of fulfilling obligations derived from a current legal relationship between you and the Data Controller.

The procedure for the revocation of consent, if applicable, will be the same as that established in the immediately preceding section for the exercise of ARCO rights.

ARGENTINA

Personal data owners located in the Republic of Argentina must observe the following specific provisions:

Rights of the Owners

The owner of personal data may exercise their rights of information, access, rectification and deletion by sending an email to derechosarcoarg@arcacontal.com , specifying the reasons for their request and including information or documentation that allows the owner of the personal data to be identified (for example, name and address), as well as a clear description of the personal data in relation to which they seek to exercise any of the rights.

The owner of personal data has the right to exercise the right of access to them free of charge at intervals of no less than six months, unless a legitimate interest is accredited for this purpose in accordance with the provisions of article 14, subsection 3 of Law No. 25,326.

The Agency for Access to Public Information has the power to address complaints and claims that are filed in relation to non-compliance with personal data protection regulations.

If the request meets the requirements, the Data Controller will respond to your access request in 10 (ten) days and to your update/rectification and deletion request in 5 (five) business days.

PERU

For the purposes of Law No. 29733 on the Protection of Personal Data, the references made in this Privacy Notice to the “Controller” should be understood as the “Owner of the Personal Data Bank” referred to in article 2, section 15 of said regulations.

Natural persons who are owners of personal data established in Peru must observe the following specific provisions:

Rights of personal data owners

The owner of personal data may exercise their rights of access, rectification, cancellation and opposition, by sending an email to derechosarcoperu@arcacontal.com , specifying the reasons for their request and including information or documentation that allows the owner of the personal data to be identified (for example, name and address), as well as a clear description of the personal data in relation to which they seek to exercise any of the rights.

Response times

- Right to Information: If the request meets the requirements previously established, the Owner of the Personal Data Bank has 8 (eight) days to respond to your request.
- Right of Access: If your request meets the requirements previously established, the Owner of the Personal Data Bank has 20 (twenty) days to respond to the owner, in case of considering your request as estimated, the response will be effective in the following 10 (ten) days after the response.
- Right of cancellation or opposition: If the request meets the requirements, the deadline to respond will be 10 (ten) from the moment of its presentation.

If the request does not meet the requirements or needs clarification, the Owner of the Personal Data Bank may request the missing information in the following 5 (five) days; otherwise, it will be considered not submitted.

ECUADOR

Personal data owners established in Ecuador must observe the following specific provisions:

Secondary purposes: there are none.

Rights of the owners

The owner of personal data may exercise their rights of access, rectification, cancellation, opposition and portability, by sending an email to ARCA CONTINENTAL to the address derechosarcoecu@arcacontal.com, specifying the reasons for their request and including the

identification information of the owner of the personal data (for example, name, identification number, address and email address), attaching their identity document, as well as a clear description of the personal data in relation to which they seek to exercise any of the rights.

Right to Portability of personal data:

In accordance with the Organic Law on the Protection of Personal Data, Personal Data Portability is considered your right to request the delivery of your personal data in a compatible, updated, structured, common, interoperable, and machine-readable format, or to transfer them to the controller you indicate.

Once the right to personal data portability has been fulfilled, we will delete your personal data unless you instruct us to retain it.

If the request does not meet the requirements or needs clarification, the Data Protection Officer may request the missing information within 5 (five) business days. You have 10 (ten) business days to respond to the request or complete the application. If you do not respond, the request will be archived and you will be notified of the rejection, but you can resubmit it.
